#### GOVERNMENTAL ACCOUNTING & AUDITING NEWS

#### **GASB STATEMENT NO. 68 Accounting and Financial Reporting for Pensions**

GASB Statement No. 68 requires governments providing defined benefit pensions to recognize, for the first time, their long-term obligation for pension benefits as a liability, and to more comprehensively and comparably measure the annual costs of pension benefits. The requirements will take effect for governments, including school districts, for fiscal years beginning after June 15, 2014 (i.e., FY2015 or later).

The long-term liability and annual costs of pension benefits for FY2015 will be calculated at the state level and communicated to all affected entities for FY2015 financial report preparation and audits. TRS and MPERA have issued a joint memo (see <a href="https://trs.mt.gov/miscellaneous/PdfFiles/Employers/Memos/2014MayTrsPersGasb.pdf">https://trs.mt.gov/miscellaneous/PdfFiles/Employers/Memos/2014MayTrsPersGasb.pdf</a>) to provide a description of the upcoming changes. The memo includes background information, what you'll need to prepare for financial reporting, next steps to consider, a glossary of terms and resources for additional information. You may want to contact your auditor to discuss this important change in financial reporting requirements.

#### PUPIL TRANSPORTATION NEWS

#### **BUS DRIVER CERTIFICATION REQUIREMENTS and BUS DRIVER QUALIFICATIONS**

In response to an audit recommendation on a 2013 Legislative Audit on Pupil Transportation, the Office of Public Instruction (OPI) amended Administrative Rule 10.7.111 Bus Driver Certification Requirements for Reimbursement (<a href="http://www.opi.mt.gov/pdf/ARM/10-7-11pro-arm.pdf">http://www.opi.mt.gov/pdf/ARM/10-7-11pro-arm.pdf</a>). The amendments clarify the process for obtaining bus driver certification.

The audit finding also recommended the establishment of criteria for, and review of, bus driver license status and character qualifications. The Board of Public Education (BPE) establishes the qualifications of bus drivers pursuant to 20-10-103, MCA, but does not have a system of licensure for school bus drivers. The BPE amended ARM 10.64.201 School Bus Driver Qualifications (<a href="http://www.opi.mt.gov/pdf/ARM/10-64-201pro-arm.pdf">http://www.opi.mt.gov/pdf/ARM/10-64-201pro-arm.pdf</a>). The amendments expand bus driver qualifications to include review and consideration of criminal background information on prospective driver employees to address safety concerns related to unsupervised contact with students and clarify that compliance with existing commercial driver license (CDL) regulations addresses review of driving records for bus drivers.

## P-CARD NEWS -

## 2014 REBATE HITS ALL TIME HIGH OF *\$124,803.55*

MASBO received \$124,803.55 for our prorated share of Illinois ASBO's Procurement Card Program rebate for 2013-2014. This is based on over \$10.9 million in P-card purchases made by Montana school districts, an increase of roughly \$2.1 million over purchases made in the previous program year. The MASBO Board of Directors approved a rebate to its 83 P-card participants equal to 1% of that district's purchases.

*Havre School District* received a free registration to the 2015 MASBO Summer Conference for having the highest purchases (\$1,530,212.99).

**Plevna School District** received a free registration to the 2015 MASBO Summer Conference for having the highest purchases per ANB (\$1,969.02).
