NEW JANUARY 31 DEADLINE FOR PAYROLL FORMS

The deadline for filing W-2 forms and some 1099 forms for calendar year 2016 has been moved up to January 31, 2017. Learn more by clicking *here*.

2017 PENSION PLAN LIMITATIONS

The Internal Revenue Service announced cost-of-living adjustments affecting dollar limitations for pension plans and other retirement-related items for tax year 2017. Technical guidance detailing these items can be found in <u>Notice 2016-62</u>.

UPDATE ON IRS E-SERVICES and SECURE ACCESS

To ensure a smooth transition, the IRS has decided to delay the October 24 date for requiring e-services users to reregister and validate their identities through Secure Access authentication. In the next few weeks, the IRS plans to have discussions with key stakeholders affected by the e-services changes to discuss security protocols and next steps in this process. *A new implementation date has not been set*. When a new date is set, the IRS will share the information widely with e-Services users. The IRS is strengthening the e-Services registration process as part of a wider effort to ensure the protection of taxpayer data and IRS systems.

IRS Announces Inflation Adjustments for Health FSAs

Yesterday, the Internal Revenue Service (IRS) announced annual inflation adjustments for many tax provisions. One adjustment we want to immediately share with you is an increase on the 2017 employee contribution maximum for employer-sponsored Health Flexible Spending Accounts (Health FSA). The maximum annual contribution will increase from the current \$2,550 to \$2,600 for plan years beginning 1/1/2017 and later.

Health FSA Contribution

Year Maximum Employee Contribution

2016 \$2,550 2017 \$2,600

What does this mean to you? If you (Employer) choose to implement this change, the Section 125 team will need to be notified to update your Section 125 Plan document prior to its plan year renewal date. The change is effective when your new plan year starts in 2017. For example: If your plan year starts 3/1/17, the new maximum will be effective with elections made for 3/1/17 and later. Please email us at the address below if you wish to increase your Plan's maximum.
